RESPONSIBLE BEVERAGE SERVER TRAINING

- TIPS (Training for Intervention Procedures) is an approved curriculum by the Nebraska Liquor Commission.
- Designed to teach the affect of alcohol on customers, evaluating behavioral cues, effective server responses and skills training
- · Four-hour course, taught by a certified instructor
- Upon completion of the course, servers/clerks are certified in this curriculum
- Businesses receive a certificate for 100% completion
- Classes are available for On-Premise Sales, Off-Premise Sales and Concessions Sales.
